INTRODUCTION

This report marks our 10th annual assessment of the scale and character of grantmaking by U.S. foundations for lesbian, gay, bisexual, transgender, and queer issues. Foundation giving to LGBTQ communities grew significantly, from \$97.2 million in 2010 to \$123 million in 2011, an increase of 27%. These dollars were distributed by 383 U.S.-based grantmakers, who collectively provided 3,728 grants to organizations and projects devoted to LGBTO issues.

This year we identified 65 more funders supporting LGBTQ issues, partly due to our ongoing efforts to increase the comprehensiveness of our research, and partly because more foundations are integrating LGBTQ communities into their grantmaking strategies. The dramatic growth in LGBTO funding far outpaced the modest increase of 2.2% in overall U.S. foundation giving. Grantmaking for LGBTO communities constituted 0.26% of all U.S. foundation dollars awarded in 2011, surpassing a quarter of a percent for the first time in the 41 years for which we have data.

A full one-third of the growth in LGBTO grantmaking was due to a \$9.5 million rise in funding of international organizations, which reached a record-high of \$28.5 million. This 50% increase in international funding reflects two trends: (1) LGBTQ funders expanding their investments in our movement at the global level; and (2) a growing number of human rights funders integrating LGBTQ rights into their portfolios.

Looking at the various LGBTO sub-populations funded, I'm pleased to report that grant dollars for transgender communities rose by 63%, from \$3 million to \$5 million, a trend that I hope will continue. We only identified a single grant of \$5,000 that directly targeted bisexuals, indicating both a continued under-funding in this area as well as a need for further research into funding, gaps, and opportunities when it comes to grantmaking impact in bisexual communities. Grantmaking specifically targeting LGBTO people of color also grew, by more than \$675,000, reaching a new high of \$14.4 million. However, grant dollars targeting people of color decreased slightly in their share of total LGBTQ grantmaking, not quite keeping pace with the dramatic growth seen overall. Grant dollars for Asian American/Pacific Islander and Latino communities increased, but, unfortunately, dollars targeting people of African descent decreased sharply, by nearly \$1.5 million. Children and youth were once again the population receiving the largest share of LGBTO grant dollars, reflecting the commitment that so many of our members have made to supporting LGBTQ youth and families.

As you dive deep into the data in this report, you'll see a number of other trends, many of them heartening and some potentially concerning. But the overall trajectory is clear: 2011 was a record-breaking year for LGBTO grantmaking in terms of total dollars invested and as a share of overall foundation grantmaking. As our movement continues to gain momentum, more and more funders are recognizing that, whatever their area of focus, they need to develop intentional strategies for advancing their objectives among LGBTQ communities. At barely a quarter of a percent of all foundation funding, we still have a long way to go but, together, I know that we will get there.




LGBTO GRANTMAKING BY U.S. FOUNDATIONS (2011)

In 2011, 383 U.S.-based grantmakers awarded 3,728 grants supporting LGBTQ organizations and projects totaling \$123 million — a 27% increase in dollars from 2010. An additional 41 grants totaling \$5,472,481 was awarded to public foundations and non-profit organizations for regranting purposes. LGBTQ grantmaking represented 0.26% of all U.S. foundation dollars awarded in 2011.²




2 Similar to previous years, independent foundations provided the most LGBTQ dollars by far, while public foundations provided the most LGBTQ grants.

² "LGBTQ grantmakers" includes grantmakers that are focused exclusively on LGBTQ issues as well as grantmakers that incorporate LGBTQ giving into their broader portfolios. Also, a handful of these LGBTQ grantmakers—notably public foundations and nonprofit organizations—both raise funds and award grants, including re-granting dollars received from other funders, which play a significant role in distributing funds to groups in the field.

In 2011, the combined funding from the top 10 LGBTQ grantmakers, by total dollars, represented 62% of total LGBTQ dollars granted. The top 10 LGBTQ grantmakers, by total grants, accounted for 37% of all LGBTQ grants awarded, six percentage points lower than in 2010.












Most LGBTQ dollars (65%) were devoted to program support, as were the majority of grants (51%).
